RE: **Request for approval of contracts to be designated as potential sole source, professional services contracts for health, behavioral health, and support services provided by non-profit contractors, as authorized by San Francisco Administrative Code Section 21.42.**

Attached for your approval is a list of contracts designated as potential sole source professional services contracts for health, behavioral health, and support services provided by non-profit contractors, as authorized by San Francisco Administrative Code Section 21.42, also referred to as a "DPH Sole Source List."

Chapter 21.42 authorizes the SF Health Commission to designate as sole source, professional services contracts for health, behavioral health and support services provided by non-profit organizations, when recommended by the Department where such services are:

- (1) Unique to the DPH
- (2) Consistent with its mission and goals
- (3) Require specialized knowledge, training, personnel, facilities or other resources that are known to be provided by a limited number of non-profit contractors.

For your approval, the list below contains the names of contractors which the Department recommends be on this list for FY19-20.

Also attached is a grid showing the typical service categories or parts of the Department for each contractor. This grid details service designations and changes from the FY18-19 list:

- Deletions of contractors who no longer have contracts with DPH;
- Additions of contractors with which DPH wishes to contract, in response to particular initiatives or specialized grant funding;
- Changes in service designations either to make the designations more accurate;
- Recommendations to keep certain contractors who do not have current contracts, but which we want to be able to contract should an immediate need arise.
