Explanation of Service Change and Variances:

This request is for approval of one as-needed contract in a pre-existing service area of facilities maintenance services, Steam Cleaning. These services were solicited through a Request For Qualifications (RFQ) for Facility Maintenance Services: RFQ 18-2020: Steam Cleaning

(Note: this RFQ also resulted in the reselection of existing vendors, who were selected under the immediately previous RFQ for Steam Cleaning.)

Under Chapter 6 of the San Francisco Administrative Code, DPH may enter into as-needed master contracts for maintenance services. These contracts are used to provide supplemental maintenance services above what DPH's regular baseline staffing is able to address, occurring during times of high activity, and unusually tight timelines for maintenance, such as emergency response, safety response, and preparation for inspection and accreditation surveys. Services may be needed at any of DPH's facilities, particularly the San Francisco Health Network, including Zuckerberg San Francisco General Hospital, Laguna Honda Hospital, DPH's 10 health centers, Behavioral Health Services clinics, and any other associated facilities.

Under the above RFQ, master contracts will be established with each of the qualified contractors selected under this RFQ according to the service areas for which they were selected (e.g. steam cleaning). When work is needed, the DPH Facilities staff will bid out each individual job on a task order.

Budgeted funds are managed by service area, with each service area's total contract amount "shared" by all of the facilities maintenance contracts for that service area (for instance, the two separate Steam Cleaning contracts will each "draw" from the same \$300,000 allocated for three years of Steam Cleaning services).

RFQ 18-2020:

Steam Cleaning (\$300,000 for 3 years),
Union Service Company (to be shared with one other Qualified vendor, Van Gelder Enterprises)

As stated in the RFQ, vendors may initially be placed in one of three categories of services:

- (1) Qualified for work at all DPH locations;
- (2) Qualified for work at non-clinical locations;
- (3) Not Qualified

Vendors placed in categories (2) or (3) may work with the Contract Analyst during the 36-month term of the RFQ to correct their submissions' insufficiencies and be placed in categories (1) or (2). Union Service Company was selected under Category 1, and is therefore qualified to work in all DPH locations.

The contract will be monitored in accordance with all applicable Departmental procedures.
