Commissioner Illig is the Director of Government Relations for Project Open Hand, and has extensive experience in San Francisco's non-profit, social service community as an executive director and program manager. He is past Chair and current Vice Chair of the Board of Directors of St. Mary's Medical Center. Commissioner Illig is a member of the San Francisco General Hospital Joint Conference Committee and Vice President of the Governing Board of the In Home Supportive Services Public Authority.

Sonia Melara is the Executive Director of Rally Family Visitation Services of Saint Francis Memorial Hospital. She serves on the part-time faculty of San Francisco State University's School of Social Work. She is the founder of CommuniQue: Management and Communications Consultants. Commissioner Melara has more than 30 years of management experience in the non-profit, public and private sectors. She has been appointed to serve under four San Francisco Mayors including as Executive Director of the Department on the Status of Women. She has also served as member and President of the San Francisco Parking and Traffic Commission, member and Chair of the San Francisco Immigrants Rights Commission and member of the Work Force Investment Board. Under President Carter she served on the National Advisory Commission on Juvenile Justice and Delinquency Prevention. Commissioner Melara is co-founder of California's first shelter for survivors of domestic violence, San Francisco's La Casa De Las Madres. She is a long term activist and has served on many non-profit boards. She is presently on the board of directors of La Cocina, a commercial kitchen business incubator for low-income women who want to start their business in the food industry. Commissioner Melara is chair of the Health Commission's Citywide Health Planning and Effectiveness Committee and a member of the Finance Committee.
